

THIRD MEETING OF HARYANA KISAN AYOOG (22ND JANUARY, 2011)

The Commission discussed in detail each of the listed agenda items and took the following decisions:

Item No.-1: Confirmation of the proceeding of the 2nd Meeting of Haryana Kisan Ayog held on 8th Nov. 2010.

The proceedings of the 2nd Meeting were confirmed.

Item No.-2: Action Taken Report on the decision taken in the 2nd Meeting of Haryana Kisan Ayog.

The commission noted the action taken. It was observed that there is no need to attach the copies of orders issued by the Commission. Regarding recruitment of Drivers, it was brought out by Vice Chancellor, HAU that they are also recruiting Drivers for the University. Written/Skill test of the applicants for the Haryana Kisan Ayog may be held along with applicants of University. It was therefore decided that the Ayog may request the University to conduct these tests for short-listing of the applicants.

Item No.-3: Purchase of items without calling quotations.

It was decided that the procedure adopted by the HAU in this regard, circulated vide letter No. CAUH/E1/2010/90/16434-16584 dt. 11.11.2010, may henceforth be followed by the Ayog.

Item No.-4: Translation work- Remuneration thereof.

It was decided that the rates in ICAR may be obtained and the decision may be taken by the Chairman.

Item No.-5: Preparation of Project Proposals/Technical Reports etc- Remuneration thereof.

It was decided that the rates applicable in ICAR, as per Johl Committee report may be obtained. Also the rates may be obtained from the National Horticulture Board, Delhi and National Horticulture Mission, Delhi and a decision may be taken by the Chairman, as appropriate.

Under any other item, it was discussed and agreed that a proposal for the delegation of powers to the Member Secretary, on lines similar to those of Deans/Directors of CCSHAU or the Director General of Agriculture/Animal Husbandry Departments of Haryana Government be put up for Commission's consideration/decision in its next meeting to be held in Gurgaon on 6th February, 2011.

The meeting ended with a vote of thanks to the chair.
